14 (ii) Considered the report dated 07.02.2015 (copy enclosed) of Inquiry Committee constituted vide endst. No./IGU/2014/9004-08 dated 09.12.2014 (copy enclosed) against Prof. Tej Singh, Prof. Nikhilesh Yadav and Dr. Subhash Chander Sharma for appropriate disciplinary action. Further to consider the report dated 03.03.2015 (copy enclosed) for appropriate disciplinary action against Prof. Nikhilesh Yadav, Dept. of English in the matter of sexual harassment to Dr. Savita Kumari, Asstt. Prof., Dept. of CSA of this University as per recommendation of the University level Committee against sexual harassment to woman.

#### Note:

That an Inquiry Committee was constituted vide endst. No. IGU/Estt./2014/9004-08 dated 09.12.2014 for conducting an enquiry based on a complaint dated 22.09.2014 lodged by Dr. Savita Kumari, Asstt. Prof., Computer Science & Applications, I.GUniversity, Meerpur, Rewari against Prof. Tej Singh, Chairperson, Department of Commerce & Prof. Nikhilesh Yadav and Dr. Subhash Chander, Associate Prof, both in the department of English, I.G. University, Meerpur, Rewari. They did not appear before the committee, but submitted a combined representation to the committee. After considering their representation the committee concluded that:

- a) Although they were given all documents (including copy of the affidavit) submitted by the complainant, still they kept denying and this amounts to telling lies in writing.
- b) Prof. Tej Singh, Prof. Nikhilesh Yadav & Dr. Subhash Chander Sharma have amply proved that they are defiant, guilty of insubordination and have indulged in gross misconduct on many counts, as alleged in the affidavit submitted by Dr. Savita Kumari, Assistant Professor, CS&A.
- c) While examining all the facts of the complaint, the committee members noticed some parts of the affidavit submitted by Dr. Savita Kumari, such as, "few senior from my University yearn for illicit personnel benefits from my side," the committee, to make sure that justice is done to all concerned, again called Dr. Savita Kumari and asked her whether she meant what the sentence conveys what it should mean in legal parlance.

Dr. Savita Kumari clarified it in writing that it was Prof. Nikhilesh Yadav who sought illicit gratifications from her.

This is a serious matter as it is tantamount to sexual harassment of a woman and calls for action as per the relevant laws of the land and the Acts & Statues of the University.

d) Moreover, joint representation submitted by the persons, who are holding group 'A' positions, is in contravention of conduct rules.

The committee, taking note of what has been deliberated upon in para (a) to (d) above, recommends that:

- (i) Stringent action for gross misconduct, insubordination, defiance and telling lies on record, may be taken against Prof. Tej Singh, Prof. Nikhilesh Yadav & Dr. Subhash Chander Sharma.
- (ii) In view of para (c), immediate action may be taken as per relevant laws of the land and the Acts & Statues of the University against Prof. Nikhilesh Yadav for causing sexual harassment of a woman.

On the basis of report of Inquiry Committee, the matter was referred to University level Committee against sexual harassment and violation to woman. The Committee asked the Prof. Nikhilesh Yadav to appear before Committee against sexual harassment to woman three times, but he did not appear before the Committee against sexual harassment. The report regarding sexual harassment to Dr. Savita Kumari submitted by the Committee is put up before the Executive Council for consideration and suitable action as recommended in the report.

RESOLVED THAT SHOW CAUSE NOTICES BE ISSUED TO PROF. TEJ SINGH, PROF. NIKHILESH YADAV AND DR. SUBHASH CHANDER SHARMA, ASSOCIATE PROFESSOR FOR MISCONDUCT ON THEIR PART AS RECOMMENDED BY THE INQUIRY COMMITTEE. FURTHER, IT WAS ALSO RESOLVED THAT PROF. NIKHILESH YADAV BE PLACED UNDER SUSPENSION AND INQUIRY MAY BE GOT DONE FROM RETIRED SESSION JUDGE IN THE MATTER OF SEXUAL HARASSMENT BY HIM AGAINST DR. SAVITA SHEORAN, ASSISTANT PROFESSOR, DEPARTMENT OF COMPUTER SCIENCE & APPLICATIONS.

14 (iii) Considered the letter dated 28.02.2015 (copy enclosed) of Dr. Subhash Chander Sharma, Dept. of English addressed to the Hon'ble Governor-Chancellor, Indira Gandhi Unversity, Meerpur (Rewari), Haryana Raj Bhawan, Chandigarh regarding his plea to quash the proceedings of 3rd meeting of the Executive Council (EC) held on 26/08/2014 with respect to table agenda item nos. 3,7,8,9,11 placed on record without the mandatory annexures (though mentioned as if attached with the items) and restrain the Hon'ble Vice- Chancellor from holding any EC Meeting in the light of communication received from the Secretary cum Registrar IGU Meerpur, explicitly stating the Vice- Chancellor not sending "his orders to provide required documents" thus amounting to denial/suppression of official information.

#### Note:

That the third meeting of Executive Council was held on 26/08/2014 and item nos. 3, 7, 8, 9, 11 of the table agenda had no annexures attached. He made a representation to the Secretary cum Registrar recording his dissent on the said items and a request to provide the missing annexures. This issue was discussed at large in the said meeting and it was found that the said annexures were available in case of copies of agenda supplied to other members but due to some omission these annexures could not found attached with his copy of agenda. This issue was resolved during that meeting of the Executive Council. Dr. Subhash Chander Sharma, Associate Professor, Dept. of English is trying to pull this issue unnecessarily. This is disregard to the proceedings of Executive Council of its meeting held on26.08.2014. This amounts to misconduct on his part and it deserved to be considered by the Executive Council for suitable disciplinary action against him. Besides this to consider to file the letter dated 28.02.2015 and his all other correspondences in this behalf.

RESOLVED THAT THE LETTER DATED 28.02.2015 FROM DR. SUBHASH CHANDER SHARMA, ASSOCIATE PROFESSOR AND HIS ALL OTHER CORRESPONDENCES IN THIS BEHALF BE FILED. FURTHER, IT WAS RESOLVED THAT ALL EMPLOYEES OF THE UNIVERSITY (TEACHING & NON-TEACHING) SHOULD NOT MAKE DIRECT CORRESPONDENCE TO THE HIGHER AUTHORITIES, IN CASE OF ANY GRIEVANCE THEY MUST FIRST APPROACH TO THEIR AUTHORITIES AND AFTER THAT IF HE/SHE IS NOT SATISFIED THAN THEY MAY SEND THEIR REPRESENTATION THROUGH PROPER CHANNEL. IT WAS ALSO RESOLVED THAT DR. SUBHASH CHANDER SHARMA BE CHARGE SHEETED FOR DISCIPLINARY ACTION FOR MISCONDUCT ON HIS PART.

14 (iv) Considered the report dated 28.01.2015 (copy enclosed) of the Inquiry Committee constituted vide endst. No. IGU/Estt./2014/8999-9003 dated 09.12.2014 (copy enclosed) in the matter of misappropriation of Rs. 23100/- by Prof. Shri Krishan and Sh. Balkar Singh, Assistant Professor, Dept. of History for appropriate disciplinary action against them.

#### Note:

That an Inquiry Committee was constituted vide endst. No. IGU/Estt./2014/8999-9003 dated 09.12.2014 on the basis of complaint lodged by Sh. Gaurav Dalal, House No. 1313, Sector-4, Extension, Rohtak regarding misappropriation of Rs. 23100/- for conducting an enquiry to find out the facts of allegations. The Inquiry Committee concluded that it has examined facts of the case thoroughly and found the complaint of Mr. Gaurav Dalal to be genuine. This is a clear case of financial embezzlement of Rs. 23100/-(Rs. Twenty three thousand & one hundred only) by Prof. Shri Krishan and Sh. Balkar Singh, Asstt. Professor, Dept. of History. The non co-operation of Prof. Shri Krishan and Sh. Balkar Singh, Asstt. Prof., Dept. of History, shows that they are either hiding the facts or falsifying the issues involved. Therefore, it is a case of insubordination and defiance of the authority of duly constituted Inquiry Committee. The committee concludes that keeping in view what has been stated above, the allegations made by Sh. Gaurav Dalal stand proved. The committee recommends that suitable disciplinary action, as per the rules of Indira Gandhi University, Meerpur, Rewari may be taken against Prof. Shri Krishan and Sh. Balkar Singh, Asstt. The proceedings of the committee was placed before the Hon'ble Vice-Chancellor, who has passed the orders to place the case of Dr. Rajesh Punia, Assistant Professor in Physics, GJUS&T, Hisar for the appointment of Associate Professor in the Department of Physics to be started in this session with the proceedings of the committee.

RESOLVED THAT THE SERVICES OF DR. RAJESH PUNIA, ASSISTANT PROFESSOR, DEPT. OF PHYSICS, GJUS&T, HISAR BE BORROWED ON DEPUTATION AS ASSOCIATE PROFESSOR IN THE DEPARTMENT OF PHYSICS TO BE STARTED BY THIS UNIVERSITY.
