After detailed deliberations, the committee has made the following recommendations: -

1. After discussion with M.D.U., Rohtak and keeping in view the status in this regard of all state Universities in Haryana, the CBCS pattern may be implemented in phased manner due to time constraints. In First phase, "Credit Base System" (CBS) may be introduced and after that "Choice Based Credit System" (CBCS) may be implemented, as there is a long process to switch over CBCS pattern i.e. the scheme of examination & syllabi are to be got approved by the concerned Board of Studies/Faculty/ Academic Council.


In view of the above, the committee recommends that the "Credit Based System"(CBS) instead of "Choice Based Credit System" (CBCS) on the basis of guidelines prescribed by the University Grants Commission may be introduced in all University courses w.e.f. session 2015-16 for the sake of uniformity.

2. We may adopt the Ordinance of "Credit Based System"(CBS) of Guru Jambheshwar University of Science & Technology, Hisar with necessary modifications, as and where required in the Ordinance keeping in view of the existing Rules & Regulations of this University.
3. Some open elective papers may be included in the Scheme and Syllabus in 3<sup>rd</sup>/4<sup>th</sup> semester of all Under-Graduate/Post-Graduate courses. The Dean of concerned


- Faculty will call a meeting of concerned Chairpersons under their Faculty and prepare a list of 2-4 Open Elective papers for all Under-Graduate/ Post-Graduate courses.
4. Open Elective papers will be of the same credit as that of other papers (Core Departmental). However, the total no. of credits for the programmes is to be kept same.
  5. Departmental Elective paper(s), if any, will continue to be there in the Scheme of existing Examination of the Course.
  6. The Course contents of each course will be divided into FOUR units by the Departments.
  7. Course objectives & course outcomes within 2-3 lines each be included in the syllabi of each course.
  8. There should be 5-7 suggested readings for each paper/course.
  9. For the end semester examinations, nine questions are to be set by the examiner. Question no.1 will be compulsory and based on the entire syllabus (all four Units). It will contain Eight Short Answer Type questions, each of two marks. Rest of the Eight questions are to be given by setting two questions from each of the Four Units of the syllabus. A candidate is required to attempt other four questions by selecting one from each of the four units. All questions including Q. No. 1 shall carry equal marks.


