

  - (i) The Women students will be entitled to avail the Maternity Leave for a period not exceeding 45 days continuously in a single stretch with the prior permission of the Chairperson of the concerned department on production of valid Medical Certificate. The leave period will be excluded from the total lectures delivered during the semester. But the concerned student has to appear in all the minor/Major Examinations etc. as per Schedule notified by the department/University.
  - (ii) However, if desired so, the student may drop the full semester but she has to complete the attendance of that drop out semester after appearing in the final semester examination and shall have to appear in the drop out semester examinations according to the Even & Odd Semester policy. In such cases, she will not be required to pay the re-admission fee and the entire semester fee (if she has already paid the drop out semester fee) to complete the attendance of the drop out semester.
  - (iii) The Women Ph.D. Research Scholars shall be provided Maternity Leave/Child Care Leave once in the entire duration of Ph.D. for up to 240 days, as prescribed in the University Grants Commission (Minimum Standards and Procedure for Award of Ph.D. Degrees) Regulations, 2016.
