- 4. Under this process, the Pre-qualification/ Technical online Bid Application as well as online Price Bid shall be invited at single stage under two covers i.e. PQQ/Technical & Commercial Envelope. Eligibility and qualification of the Applicant will be first examined based on the details submitted online under first cover (PQQ or Technical) with respect to eligibility and qualification criteria prescribed in this Tender document. The Price Bid under the second cover shall be opened for only those Applicants whose PQQ/Technical Applications are responsive to eligibility and qualifications requirements asper Tender document.

- 5. The payment for Tender Document/Bid Fee (Non-refundable) and e-Service Fee (Nonrefundable) mentioned above shall be made by eligible bidders online directly through Debit Cards & Internet Banking Accounts and the payment for Earnest Money (EMD) can be made online directly through NET BANKING/RTGS/NEFT or OTC. TERMS & CONDITIONS

1. TIME, DATE & VENUE FOR RECEIPT AND OPENING OF THE QUOTATIONS: The online bids will be opened as per schedule given under Key Dates above in the Office of **Chairperson, CSE, Indira Gandhi University, Meerpur, Rewari**.

2. MANUAL SUBMISSION OF TECHNICAL BIDS:

The quotees shall also submit manual technical bids in sealed envelope in the office of Chairperson CSE on or before the date mentioned in Key dates. Following must be superscripted on the sealed envelopes:

Envelope containing technical bid only: "TECHNICAL BID FOR SUPPLY OF Item/equipment for Electrical Lab and Semiconductor Physics Lab."

3. VALIDITY OF QUOTATION:

The bid for the work shall remain open for acceptance during the bid validity period to be reckoned from the last date of submission of the tender. If any bidder/tenders withdraws his bid/tender before the said period or makes any modifications in the terms and conditions of the bid, during the fix validity period, the earnest money shall stand forfeited. Bids shall be valid for 120 days from the date of bid closing i.e. from last date of submission of EMD. In case the last day to accept the tender happens to be holiday, validity to accept tender will be the next working day.

4. SECURITY/EARNEST MONEY DEPOSIT:

The security/earnest money equivalent to **Rs.** 16247/- (**Rs. Sixteen Thousand Two Hundred Forty Seven only**) is to be deposited by the firm. The tender without earnest money/bid security will not be opened.

5. BANK GUARANTEE (BG):

The firm selected for supply of items shall furnish Performance Guarantee/Security equivalent to 5% (five percent) of the total cost of material rounded off to nearest Rs.100.00 (Rs. hundred only) in the form of Bank Guarantee (BG)/Demand Draft guarantee to cover the cost of damaged/defected/below standard material. The Performance Guarantee/Security in the form of Bank Guarantee/Demand Draft shall be valid for a period of 180 days beyond date of completion of the complete supply and installation/assembling of the material. The Bank Guarantee/Demand Draft guarantee shall be drawn in favour of the "Registrar, IGU, Meerpur, Rewari", Payable at Meerpur submitted with the invoice to be submitted by the firm for payment, failing which invoice shall not be admitted. This amount of Bank Guarantee/Demand Draft shall be forfeited if the firm fails to replace the damaged/defected/below standard material within the stipulated period.

6. CANCELLATION OF TENDER/ORDER:

Any work, here tendered, may be withdrawn from further processing at any stage at the discretion of the competent authority without assigning any reason. The Indira Gandhi University, Meerpur, Rewari reserves the right to amend / cancel the partial/complete Order or to change qualifying requirement or to reject any or all the tenders so received without assigning any reason.

7. COST & CHARGES:

All costs / charges must be quantified and spelt out in clear terms. Non-quantified costs/charges shall not be considered and paid.

8. PAYMENT:

The payment terms shall be as under:

(a) No advance payment shall be made. The Supplier shall raise the bills after the supply and installation/assembling of the material and assembly of the items. The University shall make the payment within 30 days from the date of submission of the invoice, if the bill(s) is/are found in order and inspection report is satisfactory.

(b) Service Tax and any other statutory tax/cess/levy shall be deducted at source as per Rules prevalent at the time.

- (c) Costs/charges not mentioned in the quotation/tender shall not be paid.
- (d) Bank charges, if any, shall be borne by the supplier.
- (e) Road tax shall be paid by the supplier.

(f) The University is exempted from Custom Duty/Excise Duty/Octroi/lowered GST rate and shall issue Custom Duty/Excise Duty/Octroi Exemption/lowered GST rate Certificate to the supplier.

9. RIGHT TO ACCEPT/REJECT/NEGOTIATE THE QUOTATIONS:

The University reserves the right to accept or reject or negotiate any of the tender or conditions/items without assigning any reason. The Committee does not bind itself to accept the lowest quotation and reserve the right to reject any or all items of quotations without assigning any reason thereto. The Committee also reserves the right to accept quotations in part i.e. any item or any quantity and to reject it for the rest.

10. CLARIFICATIONS REGARDING BIDS:

During evaluation of the quotations, the Purchase Committee may, at its discretion, ask the bidder for clarification of bids. The request for clarification and the response shall be in writing, but no change in prices or substance of the tender shall be sought, offered or permitted.

11. SITE VISIT:

The Committee may visit the site of the firm and/or ask for a sample before placing orders, if feel necessary.

12. DELIVERY AND ASSEMBLING OF THE MATERIAL:

The delivery of the material shall be FOR CSE Department, Indira Gandhi University, Meerpur, Rewari. Assembly of the items shall be the responsibility of the supplier. The supplier for supply of items/equipment for Electrical Lab and Semiconductor Physics Lab shall be responsible for assembling/installation of the above said items at the place specified by the department of CSE.

13. TRANSIT OF GOODS:

Damage to goods or any other loss due to accident etc. during transit shall be the responsibility of the supplier.

14. ACCEPTANCE OF GOODS:

Goods shall be accepted subject to satisfactory report of the Inspection Committee / Committee of Experts. The goods, which are not found according to specifications, and are thus not accepted, shall be lifted back by the supplier at his own cost/risk.

15. CERTIFICATE OF NON-DEBARMENT:

The Firm quoting the rates and other terms and conditions shall append a certificate that they have not been debarred/blacklisted for any reason/ period by any Central Govt. Dept./State Govt. Dept./University/Institute/College. If so, particulars of the same may be furnished. Concealment of facts shall not only lead to cancellation of the order, but may also warrant legal action.

16. PENALTY:

In case, the Firm fails to execute the supply order on the agreed discount, and terms and conditions as contained, they shall be liable to such action as blacklisting, debarring from having any business with this University, forfeiture of earnest money/security, besides any other action as may be deemed proper by the University.

17. REPUTATION AND EXPERIENCE OF THE FIRM:

The supplier quoting the rates and other terms and conditions must have good reputation and at least three years' experience for supplying the machines. Firms with less than 25 lakhs Annual Turn Over w.r.t. this type of machines will not be allowed to participate in the bid. The following documents/information must be furnished with the quotation:

(i) Proof of supply of machines to University Department/ Govt. Educational Institutions during the last three years.

(ii) Annual Turn Over in respect of machines and over all Turn Over of the firm, separately.

(iii) Copies of own PAN/TAN Numbers and Income Tax clearance certificate.

(iv) Copies of own GST/Sales Tax Number along with latest Sale Tax clearance certificate.

18. TERMS AND CONDITIONS PRINTED ON QUOTATION/INVOICE:

Terms and conditions printed on Quotation/Invoice of the Agency, if any, shall not be binding on the University, except those mentioned specifically on the supply order, and acceptance of the order by the Firm shall be construed as their agreement to all the terms and conditions.

INSTRUCTIONS TO BIDDER ON ELECTRONIC TENDERING SYSTEM

These conditions will over-rule the conditions stated in the tender documents, wherever relevant and applicable.

1. Registration of bidders on e-Procurement Portal:-

All the bidders intending to participate in the tenders process online are required to get registered on the centralized e - Procurement Portal i.e. https://etenders.hry.nic.in/nicgep/app. Please visit the website for more details.

2. Obtaining a Digital Certificate:

- 2.1. The Bids submitted online should be encrypted and signed electronically with a Digital Certificate to establish the identity of the bidder bidding online. These Digital Certificates are issued by an Approved Certifying Authority, by the Controller of Certifying Authorities, Government of India.
- 2.2. A Digital Certificate is issued upon receipt of mandatory identity (i.e. Applicant's PAN Card) and Address proofs and verification form duly attested by the Bank Manager / Post Master / Gazetted Officer. Only upon the receipt of the required documents, a digital certificate can be issued. For more details please visit the website https://etenders.hry.nic.in/nicgep/app.
- 2.3. The bidders may obtain Class-II or III digital signature certificate from any Certifying Authority or Sub-certifying Authority authorized by the Controller of Certifying Authorities or may obtain information and application format and documents required for the issue of digital certificate from.
- 2.4. The bidder must ensure that he/she comply by the online available important guidelines at the portal https://etenders.hry.nic.in/nicgep/app for Digital Signature Certificate (DSC) including the e-Token carrying DSCs.
- 2.5. Bid for a particular tender must be submitted online using the digital certificate (Encryption & Signing), which is used to encrypt and sign the data during the stage of bid preparation. Unless the certificates are revoked, it will be assumed to represent adequate authority of the user to bid on behalf of the firm in the department tenders as per Information Technology Act 2000. The digital signature of this authorized user will be binding on the firm.
- 2.7. In case of any change in the authorization, it shall be the responsibility of management / partners of the firm to inform the certifying authority about the change and to obtain the digital signatures of the new person / user on behalf of the firm / company. The procedure for application of a digital certificate however will remain the same for the new user.
- 2.8. The same procedure holds true for the authorized users in a private/Public limited company. In this case, the authorization certificate will have to be signed by the directors of the company.

3. <u>Pre-requisites for online bidding</u>:

In order to operate on the electronic tender management system, a user's machine is required to be set up. A help file on system setup/Pre-requisite can be obtained from E-procurement System Govt. of Haryana or downloaded from the home page of the website - https://etenders.hry.nic.in/nicgep/app. The link for downloading required java applet & DC setup are also available on the Home page of the e-tendering Portal.

4. Online Viewing of Detailed Notice Inviting Tenders:

The bidders can view the detailed N.I.T and the time schedule (Key Dates) for all the tenders floated through the single portal e Procurement system on the Home Page at https://etenders.hry.nic.in/nicgep/app.

5. **Download of Tender Documents**:

The tender documents can be downloaded free of cost from the e-Procurement portalhttps://etenders.hry.nic.in/nicgep/app.

6. Key Dates:

The bidders are strictly advised to follow dates and times as indicated in the online Notice Inviting Tenders. The date and time shall be binding on all bidders. All online activities are time tracked and the system enforces time locks that ensure that no activity or transaction can take place outside the start and end dates and the time of the stage as defined in the online Notice Inviting Tenders.

7. <u>Online Payment of Tender Document Fee, eService fee, EMD fees & Bid</u> <u>Preparation & Submission (PQQ/ Technical & Commercial/Price Bid)</u>:

(i) Online Payment of Tender Document Fee + e-Service fee:

The online payment for Tender document fee (Non-refundable), eService Fee (Non-refundable)&EMD can be done using the secure electronic payment gateway. The Payment for Tender Document Fee and eService Fee shall be made by bidders/ Vendors online directly through Debit Cards & Internet Banking Accounts and the Payment for EMD shall be made online directly through NET BANKING/RTGS / NEFT& OTC. The secure electronic payments gateway is an online interface between contractors and Debit card / online payment authorization networks.

(ii) **PREPARATION & SUBMISSION Of online APPLICATIONS/BIDS**:

Detailed Tender documents may be downloaded from e-procurement website (https://etenders.hry.nic.in/nicgep/app) and tender mandatorily be submitted online.

Scan copy of Documents to be submitted/uploaded for Prequalification or Technical bid under online PQQ/ Technical Envelope: The required documents (refer to DNIT) shall be prepared and scanned in different file formats (in PDF /JPEG/MS WORD format such that file size is not exceed more than 10 MB) and uploaded during the on-line submission of PQQ or Technical Envelope.

FINANCIAL or Price Bid PROPOSAL shall be submitted mandatorily online under Commercial Envelope and original not to be submitted manually)

Guideline for Online Payments in e-tendering

Post registration, bidder shall proceed for bidding by using both his digital certificates (one each for encryption and signing). Bidder shall proceed to select the tender he is interested in. On the respective Department's page in the e-tendering portal, the Bidder would have following options to make payment for tender document &EMD:

- A. Debit Card
- B. Net Banking
- C. RTGS/NEFT

Operative Procedures for Bidder Payments

(A) **Debit Card**.

The procedure for paying through Debit Card will be as follows:

(i) Bidder selects Debit Card option in e-Procurement portal.

(ii) The e-Procurement portal displays the amount and the card charges to be paid by bidder. The portal also displays the total amount to be paid by the bidder.

(iii) Bidder clicks on "Continue" button

(iv) The e-Procurement portal takes the bidder to Debit Card payment gateway screen.

(v) Bidder enters card credentials and confirms payment

(vi) The gateway verifies the credentials and confirms with "successful" or "failure" message, which is confirmed back to e-Procurement portal.

(vii) The page is automatically routed back to e-Procurement portal

(viii) The status of the payment is displayed as "successful" in e-Procurement portal. The e-Procurement portal also generates a receipt for all successful transactions. The bidder can take a print out of the same,

(ix) The e-Procurement portal allows Bidder to process another payment attempt in case payments are not successful for previous attempt.

(B) Net Banking.

The procedure for paying through Net Banking will be as follows:

- (i) Bidder selects Net Banking option in e-Procurement portal.
- (ii) The e-Procurement portal displays the amount to be paid by bidder.
- (iii) Bidder clicks on "Continue" button

(iv) The e-Procurement portal takes the bidder to Net Banking payment gateway screen displaying list of Banks

(v) Bidder chooses his / her Bank

(vi) The Net Banking gateway redirects Bidder to the Net Banking page of the selected Bank

(vii) Bidder enters his account credentials and confirms payment

(viii) The Bank verifies the credentials and confirms with "successful" or "failure" message to the Net Banking gateway which is confirmed back to e-Procurement portal.

- (ix) The page is automatically routed back to e-Procurement portal
- (x) The status of the payment is displayed as "successful" in e-Procurement portal.

The e-Procurement portal also generates a receipt for all successful transactions. The bidder can take a print out of the same. (xi) The e-Procurement portal allows Bidder to process another payment attempt in case payments are not successful for previous attempt.

(C) RTGS/ NEFT.

The bidder shall have the option to make the EMD payment via RTGS/ NEFT. Using this module, bidder would be able to pay from their existing Bank account through RTGS/NEFT. This would offer a wide reach for more than 90,000 bank branches and would enable the bidder to make the payment from almost any bank branch across India.

(i) Bidder shall log into the client e-procurement portal using user id and password as per existing process and selects the RTGS/NEFT payment option.

(ii) Upon doing so, the e-procurement portal shall generate a pre-filled challan. The challan will have all the details that is required by the bidder to make RTGS-NEFT payment.

(iii) Each challan shall therefore include the following details that will be pre-populated:

- Beneficiary account no: (unique alphanumeric code for e-tendering):
- Beneficiary IFSC Code:
- Amount:
- Beneficiary bank branch:
- Beneficiary name:

(iv) The Bidder shall be required to take a print of this challan and make the RTGS/NEFT on the basis of the details printed on the challan.

(v) The bidder would remit the funds at least T + 1 day (Transaction + One day) in advance to the last day and make the payment via RTGS / NEFT to the beneficiary account number as mentioned in the challan.

(vi) Post making the payment, the bidder would login to the e-Tendering portal and go to the payment page. On clicking the RTGS / NEFT mode of payment, there would be a link for real time validation. On clicking the same, system would do auto validation of the payment made.

(D) **Over-the-Counter (OTC)**.

This solution shall allow the bidder having account with ICICIBank, to make the payment from any CMS enabled Branch of ICICI Bank in India. Bidders can make the payment via cash(if amount is<=₹ 49,999), Demand Draft or ICICI Bank Cheque.

The procedure for paying through OTC mode is as follows:

(i) Bidder selects Over-the-Counter remittance option in e-Procurement portal.

(ii) The e-Procurement portal displays the amount to be paid. Bidder chooses the bank account no. for refund of the amount.

(iii) Bidder clicks on "Continue" button.

(iv) The e-Procurement portal displays the details of payment. Bidders clicks on "print_challan" and prints the OTC challan.

(v) Bidder submits the OTC challan at the counter of any designated branch of ICICI Bank with Cash / Demand Draft / ICICI Bank Cheque (Payment in cash is allowed up to Rs. 49,999/-).

(vi) ICICI Bank verifies the URN (format to be discussed and decided) and Amount with e- Procurement portal prior to accepting the payment.

(vii) On successful verification from e-Procurement portal, ICICI Bank accepts the payment. In case of failure, ICICI Bank shall return back the OTC challan and payment to the Bidder.

(viii) ICICI Bank will commit the payment transaction (in case of successful verification from e- Procurement portal) and sends the Bank Transaction Number (I-Sure Reference Number) online against the URN and Amount.

(ix) ICICI Bank will generate receipt for the payment transaction and issues the same to theBidder.

(x) The e-Procurement system updates the bank transaction number against the URN and Amount based on details sent by ICICI Bank online prior to generation of receipt.

(xi) The status of payment will be displayed as "verification successful" in e-Procurement portal, when the bidder clicks on verification option in the portal

(xii) Bidder would be required to upload the scan copy of receipt as received from ICICI Bank as part of proof in E-Procurement System portal before submitting the tender
