Further after last date, no internal awards will be accepted. There is no need to submit hard copy in the Result Branch. Colleges/Institutes have to keep the copies of the online uploaded internal assessment along with the original copies of the same in their office up to 02 years after conducting the said examinations. Timely uploading of internal assessment awards shall be helpful in preparing the results, avoiding any delay.

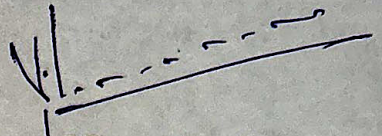
Principals/Directors of Colleges/ are required to send a soft copy of online awards at result@igu.ac.in within 07 days after last date, positively. Colleges / Institutes are required to publish online uploaded list on their display board/website also.

If any students is not showing on the portal then kindly check the subjects in their admit cards first, if any type of issue such as students not showing on portal, max marks are not correct, grading issue, then kindly send your mail with **screen shot of portal & copy of the admit card** at result@igu.ac.in at least **03 days** before the last date of closing the Portal. Also **kindly lock the awards after checking with original awards given by examiner, no query regarding unlocking & updating of Internal Assessment awards will be consider after last date.**

Note: 1. After the last date for uploading of the internal assessment marks, a penalty late fee as per details given below per student per subject shall be levied upon the concerned College / Institute after the last date for uploading of the internal assessment marks and this penalty/late fee shall not be charged from the student by the College/Institute

Sr. No.	Details	Penalty Late Fee
1	Upto 10 days from last date of filling the Internal Awards	Rs. 100/- per student per subject
2	Upto 20 days from last date of filling the Internal Awards	Rs. 200/- per student per subject
3	Upto 30 days from last date of filling the Internal Awards	Rs. 500/- per student per subject
4	After 30 days from last date of filling the Internal Awards and before the commencement of the next end-term semester/year examinations to be conducted by the university	Rs. 1000/- per student per subject

2. The Principals/Directors of the concerned Colleges/Institutes shall ensure that the students who have been awarded "0" marks or are marked "Absent" in the Internal Assessment shall not be allowed to appear in the End-term examinations of session May-2026.

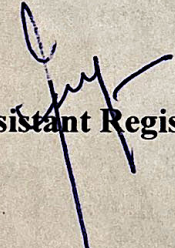
