Last date for submission of CR with late fees 750/- per student upto	15.09.2023
Last date for submission of CR with late fees 1500/- per student upto	30.09.2023
Last date for submission of CR with late fees 2500/- per student upto	14.10.2023
<i>For one week before commencement of examination and after that no request will be considered in any circumstances: Rs. 5000/- per student with the permission of the Vice-Chancellor.</i>	

Note: On above proposed schedule dates, if holiday may observe in the University, the next working day will be considered as the last date.
