It is notified for information of all concerned that the Hon'ble Vice-Chancellor has been pleased to approve the following schedule for admission against the vacant seat(s) in LL.B. & P.G. programme(s) (except M.B.A.) for the session 2026-27:

3.	Date of reporting in the concerned UTD, verification of the documents and fee submission	28.07.2026 (upto 05:00 p.m.)
4.	Supply the details of category wise vacant seat(s) by the concerned UTD to Academic Branch as well as UCC	29.07.2026 (after 05:00 p.m.)

- After completion of above schedule, the department(s) having valid waiting list of candidate(s) shall fill-up the vacant seat(s), if any strictly through the waiting list. The concerned University Teaching Department (UTD) shall submit a proposal for filling the vacant seat(s) along with a draft schedule of admission category-wise details of vacant seat(s) and merit list of candidate(s) in waiting list.
- The department where the waiting list is exhausted, the vacant seat(s) shall be filled on the basis of first-come-first-serve by following the procedure as under:
 - The candidates are required to fill the online application form by visiting the concerned department/UCC and submit the hard copy of the said application form in the concerned UTD alongwith requisite fee.
 - The concerned Chairperson(s) of the respective UTD(s) shall ensure that the category-wise details of vacant seat(s), if any, are published on the University portal.
 - The concerned Chairperson(s) shall make necessary arrangements to maintain a serial-wise register of all admission application forms received in the department, clearly recording the date and exact time of receipt of each application. Admissions shall be offered strictly in the order of such serial number and time of receipt.
 - In the event that two or more candidates submit their admission forms at the same time, preference shall be given to the candidate placed higher in the merit list. The concerned Chairperson shall record the reasons for such preference on the respective admission form(s) to ensure fairness, transparency, and proper maintenance of records.
- The last date for admission in all programme(s) will be 14.08.2026.

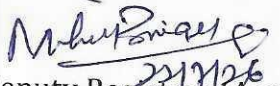
