**For Admission to Ph.D. Programmes Through Entrance Test**

In continuation of admission notice endst. No. IGU/Acad./2026/71-100 dated 09.01.2026, it is notified for information of all concerned that the Hon'ble Vice-Chancellor is pleased to approve the revised admission schedule for admission in Ph.D. programme in various UTDs under **PHASE-II (Through Entrance Test)** for the session 2025-26 as under:

**Note:**

- To qualify, candidates must secure at least 50% marks in the Entrance Test. *A relaxation of 5% marks (from 50% to 45%) in the entrance test will be granted to candidates belonging to SC/ST/BC-A & BC-B (Non-Creamy Layer), Differently-abled categories and EWS of Haryana.*
- The entire admission process shall be carried out by the concerned Department.
- Employed candidate are required submit the No Objection Certificate from his/her employer in the prescribed format (Annexure – A/B available in Information Brochure for admission to Ph.D. 2025-26- for exempted category) at the time of Counseling, failing which his/her candidature shall be cancelled.
- The foreign students may appear for interview through online mode.
- Eligibility, procedure of preparation of merit list & admission and other guidelines outlined in the Information Brochure for admission to Ph.D. 2025-26 (for exempted category) shall remain unchanged.

**Guidelines for 1<sup>st</sup> Physical counseling:**

- The candidates shall report in the concerned Department and mark attendance up to 11.00 a.m. during physical presence in the department. Only those candidates who shall mark their attendance with in stipulated time shall be considered for 1<sup>st</sup> Physical

### Guidelines for Open Physical counseling:

- The candidates shall report in the concerned Department and mark attendance up to 11.00 a.m. during physical presence in the department. Only those candidates who shall mark their attendance within stipulated time shall be considered for Open Physical counseling.
- The interview for those eligible candidates who could not appear in the interview held on 27.01.2026 will be conducted from 11:00 a.m. onwards and merit list will be displayed on the Notice Board of the concerned department up to 01:00 pm.
- First seats will be offered to the candidates in their categories/sub-categories as per provision available in the Information Brochure. For example, if any seat remains vacant in sub-categories BC(A) and BC(B) or SC and SC(D) and eligible candidates are not available in the respective categories, the same will be filled up through the candidates belonging to other sub-category in BC or SC respectively.
- If the eligible candidates are not available, then the remaining seats shall be automatically converted into Haryana General Open Category (HOGC) and shall be filled accordingly.
- If the eligible candidates HOGC are not available, then the remaining seats shall be automatically converted into All India Open Category (AIO) and shall be filled accordingly.
