



## **REVISED NOTIFICATION**

It is notified for information of all concerned that on the request of students, the Hon'ble Vice-Chancellor, has accorded permission to grant a special chance/mercy chance to the students of M.Ed. course for the session **2017-19, 2018-20, 2019-21, 2020-22 & 2021-23**, who couldn't pass the **M.Ed. Course** within the admissible chances as per Ordinance(s) of the respective Course, subject to fulfilment of following criterion/conditions:

- 1) The students who enrolled himself/herself for their particular course in the year as mentioned above for M.Ed. Course and availed all his/her admissible chances as provided in the scheme of examination/Ordinance, stands availed/exhausted till the last examination i.e. May, 2025 shall only be eligible for this special chance/mercy chance. If anyone who has any admissible chance to pass the degree at his/her credit, as of now, shall not be eligible for this special chance/mercy chance.
- 2) The Last Date for filling the examination form on the University Portal for this special/ mercy chance has been extended up to **16.02.2026**.
- 3) For this special chance/mercy chance, the details of semesters and examination fee to be charged is as under:

- 4) The students are also advised that before submission of online examination form and fee, they must check/ensure their eligibility and in case of any doubt, they must confirm it from the Result Branch. If any **“INELIGIBLE STUDENT/CANDIDATE”** submits his/her examination form and fee without ensuring his/her eligibility, then he/she will be solely responsible for the same and the examination fee deposited by him/her will not be refunded by the university in any case. All the student desirous of availing this chance are advised to read the following:
  - i) This special chance/mercy chance is admissible to complete the **M.Ed. (programme)** for such students who have re-appear in one or more papers (subject).

- ii) The semester examination of the mercy students will be held along with regular/reappear odd semester examinations and even semester examinations with regular/reappear examinations scheduled to be held with even semester with the existing syllabus where ever applicable and the Schedule will be notified on the University Website accordingly.
- iii) The examination forms & fee of mercy/special chance shall be filled through online mode.
- iv) The result will be declared depending on administrative requirements of the University and students will have no claim for early declaration of result.
