Sub: Regarding offering of Ph.D. seats to the Faculty of the Affiliated Colleges.

Sir/Madam,

Kindly refer to the subject cited matter.

In this connection, I am directed to inform you that as per provisions of Clause-10 of Ph.D. Ordinance 2025-26 of the University, Assistant Professor/Associate Professor/Professor with Ph.D. working in the affiliated colleges of the University may be recognized as Research Supervisor.

Post-graduate Departments of colleges must have Ph.D. qualified teachers/scientists/other academic staff in the department concerned along with required infrastructure, supporting administrative and research promotion facilities stipulated as under:

- a) In case of Science and technology discipline, exclusive research laboratories with sophisticated equipments as specified by the Institution concerned with the provision of adequate space per research scholar along with computer facilities and essential software, and uninterrupted power and water supply;
- b) Earmarked library resources, including the latest books, Indian and International journals, e-journals, extended working hours for all disciplines, and adequate space for research scholars in the Department/library for reading, writing, and storing study and research materials.
- c) Colleges may also access the required facilities of the neighbouring Institutions/Colleges, or of those Institutions/Colleges/R&D laboratories/ Organizations which have the required facilities.

The teachers of the affiliated Colleges may be intimated to submit their request to the Chairperson of the UTDs latest by 03.03.2026, through Principal of their respective college alongwith undertaking to be given by the Principal of respective college regarding availability of

all requisite infrastructure/facility, to ascertained their eligibility of appointment as Research Supervisor through Departmental Committee.

A committee constituted by the Hon'ble Vice-Chancellor will visit the affiliated colleges to ensure the research facilities in the college.
