Subject: Free of cost verification of the genuineness of the educational certificates.

This is in continuation of the UGC communication dated 30th May 2024, regarding the verification of educational certificates of newly recruited Assistant Section Officers (DRASOs) through the Combined Graduate Level Examination (CGLE) conducted by the Staff Selection Commission (SSC). A copy of the earlier communication is attached for reference.

It is emphasized once again that verification of educational qualifications, in addition to other prescribed verifications, is a prerequisite for confirmation of the appointed officers in the Government service. In the interest of the Government, it is necessary to ensure the genuineness of candidates. Therefore, it should be the obligation of each educational institute, including private/deemed universities, to conduct this verification free of cost.

Therefore, all the Central/State/Deemed/Private Universities and other Higher Education Institutions are hereby requested to undertake free of cost verification of the genuineness of the educational certificates for all recruitments to Central Government posts, irrespective of recruiting agency, whenever any Ministry/Department or any other Central Government organization makes a request to this effect.
