- Confirmed the minutes of 15<sup>th</sup> meeting (emergent) held on 13<sup>th</sup> June 2018 and 16<sup>th</sup> meeting (emergent) held on 11.10.2618 of the Executive Council (Annexure 1, already circulated).
- Noted the follow up action report on the decision taken by the Executive Council in its meeting held on 13.06.2018 (Annexure - 2, already circulated).
- Considered the report dated 26.11.2016, regarding enquiry of complaints made by Mr. Mukesh and Mr. Parkash relating to admission in Ph.D. (History) during the session 2014-15, submitted by a Enquiry Committee constituted by the Vice-Chancellor (Annexure - 3, already circulated).

It is submitted that the University invited applications for admission in Ph.D. course in the subject of History for the session 2014-15 in accordance with the positions of the Prospectus. The Department prepared overall merit list, on the basis of criteria given in the Prospectus containing the names of 10 candidates. The Chairperson, Department of History, itself decided that 06 candidates were in order of merit. Out of 06 candidates, 3 candidates shown at Sr. No. 3,4 & 5 denied to take admission, as they have already been enrolled in the M.Phil Programme. Thereafter, 2 candidates namety Mr. Parkash & Mr. Mukesh, made complaint through CM Window alleging that they have been given much less marks in the interview, The Vice-Chancellor constituted a Committee consisting of

Dr. Amar Singh (Retd. Prof. of History) and Dr. S.C. Malik (Prof. in Statistics) both from M.D. University, Rohtak. The meeting of the said Enquiry Committee held on 20.11.2016 at Faculty House of M.D.University, Rohtak and submitted its report. The recommendations given by the Committee are as under:

- (a) The University/Department should have given admission to 10 candidates for the course work for Ph.D. as per the admission prespectus for the session 2014-15, instead of only three, against the total recommended six candidates, in order of merit.
- (b) From the records and the action taken in admitting the students in course-work for Ph.D. (History) - preparing and displaying the merit list, conducting interviews etc. - the Admission Committee has failed in complying the provisions of the Prospectus for the session 2014-15 while depriving the rights of the eligible candidates covered in the merit list. In view of this, the University may initiate disciplinary actions against the Admission Committee as may deem it appropriate as per rules

RESOLVED THAT THE RECOMMENDATIONS OF THE ENQUIRY COMMITTEE BE APPROVED. FURTHER RESOLVED THAT THE CHARGE SHEET BE SERVED TO THE ERRING OFFICIALS IN TERMS OF SERVICE AND CONDUCT RULE.

4. Considered the report of Enquiry Committee constituted by Vice-Chancellor of M.D. University, Rohtak in the complaint made by Sh. Gaurav Dalal received from Assistant Registrar(Conduct), M.D. University, Rohtak vide letter No. Conduct/2017/AC-V/4717 dated 24.05,2017 and an another complaint received through CM Window vide CM Grievances No. CMOFF/N/2017/124239 made by Sh. Sandeep Dalal, Advocate (Annexure -4, already circulated).

Mr. Gaurav Dalal S/o Sh. Baljeet Singh, H.No. 1313, Sector-04 Ext., Rohtak made a complaint of financial embezzlement/misuse of University fund by Prof. Shri Krishan and Dr. Balkar Singh both Department of History of the then LG.P.G.R.C., Meerpur, Rewari and now LG. University, Meerpur, Rewari by way of appointing him as observer in the examination held in May/June, 2013 vide this letter dated 05.12.2014. The complainant had also submitted an affidavit in this regard.

The Vice-Chancellor constituted an enquiry committee to enquire into the allegations made in the complaint by Sh. Gaurav Dalat vide letter No. 1GU/Estt./2014/8998-9003 dated 09.12.2014. The enquiry committee submitted its report. The report of the Enquiry Committee was considered by the Executive Council vide its resolution No. 14(iv) dated 30.03.2015 and in terms of the decision of the Executive Council both the faculty members i.e. Prof. Shri Krishan and Dr. Balkar Singh were served charge sheet vide this office letter No. 1GU/Estt./2015/1349 dated 16.04.2015 and IGU/Estt./2015/1348 dated 16.04.2015. Prof. Shri Krishan and Dr. Balkar Singh also filed a CWP No. 12492/2015 at Hon'ble High Court Punjab & Haryana, Chandigarh on this issue. Later on the case was withdrawn by the petitioner with the liberty to file a fresh one on the same cause of action, if his grievance is not fully redressed. The reply of the charge sheets were placed before the Executive Council and the Executive Council vide its resolution No. 36 dated 13.08.2015 resolved that "the case be kept pending to re-look into the matter and to submit complete report". In the

meantime, the office also received the same complaint by Sh. Gaurav Dalal through C.M. Window alleging for not taking action against the faculty members after having proved the allegations by the enquiry committee. The complaint received through C.M. Window was placed before the committee already constituted to enquire in to the allegations. The meeting of the said committee was held on 22.02,2017 and submitted its report. The issue was discussed with the Vice-Chancellor by the Dean, Academic Affairs and pointed out that the enquiry on this issue is being initiated by M.D. University, Rohtak because this is a case of financial embezzlement of M.D. University, Rohtak relating to the period when the IGU was IGPGRC Meerpur of M.D. University, Rohtak (prior to 9/2013).

A letter received from Assistant Registrar (Conduct) of M.D. University, Rohlak alongwith enquiry report, requesting that recovery may be made from the faculty members and strict disciplinary action may be initiated against them, was considered by the Vice-Chancellor. He has ordered to place the enquiry report before the Executive Council for consideration.

The matter was considered by the Executive Council its moeting held on 06.09.2017 vide item No. 29(7) and resolved as under:

"RESOLVED THAT (I) ALL CASE(S) WITH COMPLETE DOCUMENTS BE PLACED BEFORE THE EC IN ITS NEXT MEETING, AND

(II) LEGAL OPINION IN THESE CASES MAY ALSO BE SOUGHT FROM THE ADVOCATE(S) OF HIGH COURT/SUPREME COURT/RETIRED JUDGE, IF NOT OBTAINED.

AND A COPY OF THE AGENDA BE SENT TO THE MEMBERS WELL IN ADVANCE TO ENABLE THEM TO STUDY CASE(S) CAREFULLY,"

The Legal opinion has been sought from the advocate and he has advised that a VC cannot constitute a committee over the recommendation of the EC of MDU Rohtak.

Mr. Gaurav Dalal S/o Sh. Baljeet Singh, H.No. 1313, Sector-04 Ext., Rohtak made a complaint of financial embezzlement/misuse of University fund by Prof. Shri Krishan and Dr. Balkar Singh both Department of History of the then I.G.P.G.R.C., Meerpur, Rewari and now I.G.University, Meerpur, Rewari by way of appointing him as

observer in the examination held in May/June, 2013 vide this letter dated 05.12.2014. The complainant has also submitted an affidavit in this regard.

The Vice-Chancellor constituted an enquiry committee to enquire into the allegations made in the complaint by Sh. Gaurav Dalal vide letter No. IGU/Estt./2014/8998-9003 dated 09:12:2014. The enquiry committee submitted its report. The report of the Enquiry Committee was considered by the Executive Council vide its resolution No. 14(iv) dated 30.03.2015 and in terms of the decision of the Executive Council both the faculty members i.e. Prof. Shri Krishan and Dr. Balkar Singh were served charge sheet vide this office letter No. IGU/Estt./2015/1349 dated 16.04.2015 and IGU/Estt./2015/1348 dated 16.04.2015 . Prof. Shri Krishan and Dr. Balkar Singh also filed a CWP No. 12492/2015 at Hon'ble High Court Punjah & Haryana, Chandigarh on this issue. Later on the case was withdrawn by the petitioner with the liberty to file a fresh one on the same cause of action, if his grievance is not fully redressed. The reply of the charge sheets were placed before the Executive Council and the Executive Council vide its resolution No. 36 dated 13.08.2015 resolved that "the case be kept pending to re-look into the matter and to submit complete report". The issue was discussed with the Vice-Chancellor by the Dean Academic Affairs and pointed out that the enquiry on this issue is being initiated by M.D.University, Rohtak because this is a case of financial embezzlement of M.D. University, Rohtak relating to the period when the IGU was IGPGRC, Meerpur of M.D. University, Robtak (prior to 9/2013).

A letter received from Assistant Registrar (Conduct) of M.D. University, Rohtak along with enquiry report, requesting that recovery may be made from the faculty members and strict disciplinary action may be initiated against them, was considered by the Vice-Chancellor. He has ordered to place the enquiry report before the Executive Council for consideration.
