(LEET) & M.C.A.) will be made through Physical Counseling and the concerned department will notify the merit list of category wise eligible candidates on the Notice Board of the Department as well as on the University Website as per the schedule given below:

- 2. The Physical Counseling will be held as per the past practices adopted for physical counseling. If the seats remain vacant after 3rd Physical Counseling, the same will be filled up during the Open Counseling as per procedure given below:
 - i. First the seats will be offered to the candidates of their respective category from 09:00 a.m. to 11:00 a.m.
 - ii. The remaining seats shall be automatically converted into Haryana Open General Category and shall be filled accordingly.
- 3. In the various P.G. programmes in which Entrance Test was not held due to less number of applications, the candidates are required to submit the hard copy of online application form alongwith photocopies of all relevant documents such as DMCs of 10th, 12th, all semesters of Graduation, Category Certificate, Residential Certificate/Domicile, Character Certificate, gap year etc. in the office of concerned department latest by 17.11.2020 upto 05:00 p.m. The schedule of display of merit list and Physical Counseling for these programmes will be decided later on. Fresh applications are invited in those programmes where the entrance tests are not conducted. The application form alongwith relevant documents and processing fee (Rs. 250/- for SC/BC category and Rs. 1000/- for all other categories) in the form of Demand Draft in favour of Registrar, I.G.U., Meerpur or Bank Challan of O.B.C. Bank, I.G.U. Campus, Meerpur may reach to the department concerned by 17.11.2020 upto 05:00 p.m. In such cases, the preference will be given to those applicants who have applied before 20.10.2020.
- 4. The condition of minimum passing marks by the candidates in the Entrance Test held for admission in various UG/PG programmes is waived off. However, the candidates who have secured zero and negative marks in the entrance test are not eligible for admission.
- 5. The Chairperson of the concerned Department must ensure to follow the norms of Social Distancing during the Physical Counseling by the candidates and teaching/non-teaching staff members.
- 6. The fee for admission in respective programme shall be deposited by the candidates on the day of Physical Counseling in the prescribed fee challan provided by the concerned University Teaching Department.
