Work : Providing and Fixing of Wall Paneling with 3.5-4.0 mm thick veneering duly polished in the Moot Court for Department of Law.

1/NS	P&F of wall paneling up to 7' height with finished face of 3.5-4.0 mm thick (AP/EP series of Garnet or equivalent) veneer. The veneer shall be pasted on 12 mm thick water proof, ante termite grade ply of Century/Duro/Green ply make, using adhesive, necessary headless nails, screws etc. The ply shall be fixed on G.I. framework (Make -Gyp steel/India Gypsum or Gabson) comprising of 48 mm studs (0.55 mm thick having one flange of 34 mm and another flange of 36 mm made of GI steel) placed at 600 mm centre to centre both ways (Maximum or less wherever required) in 50 mm floor and ceiling channel (0.55 mm thick having equal flange of 32 mm made of GI steel) in desired profile (Straight or Curved). The veneer shall be polished with MRF melamine sealer followed by two coats of melamine (matt polish Asian make)duly grooved as required as per site condition, the top should also be covered with teak wood beading of proportionate thickness duly polished with same colour & 25 mm dia. conduit pipes are also fixed as and where required.
