It is notified for information of all concerned that the Hon'ble Vice-Chancellor has been pleased to approve the following schedule for filling-up the application forms for admission against the vacant seats in the Departments/Courses mentioned in the Annexure – I:

Note:

- 1. The Departments where the admissions are made through Entrance Test, preference will be given to the candidates who have already appeared for Entrance Test and the admission of such candidates will be made on merit prepared on the basis of marks obtained in the Entrance Test. The candidates, who have appeared in the Entrance Test held for admission for any particular programme, are also required to submit hard copy of the application form alongwith all documents and copy of fee deposited by them at the time of online form submission. After the list of candidates who appeared in the Entrance Test is exhausted and seats still remain vacant, the same will be filled amongst the fresh candidates and the admission will be made on the basis of Academic Merit.
- 2. Fresh applications are invited in the programmes/courses where Entrance Tests were not conducted. The candidates who have applied for admission in the programmes where Entrance Test was not held for admission i.e. M.A. English, M.A. Hindi, M.A.

Economics, M.S.W. and M.Sc. Yoga are not required to apply again. However, they will be consider within overall merit list (New and Old applicants). If any candidate not submits the hard copy of application form in the concerned department earlier, then he/she is required to submit the same before the last date i.e. 10.12.2020. Such candidates can also submit the final result of qualifying examination.

- 3. The Physical Counseling will be held as per the past practices adopted for physical counseling. If the seats remain vacant after 3rd Physical Counseling, the same will be filled up during the Open Counseling as per procedure given below:
 - i. First the seats will be offered to the candidates of their respective category from 10:30 a.m. to 12:30 p.m.
 - ii. The remaining seats shall be automatically converted into Haryana Open General Category and shall be filled accordingly.
- 4. The Chairperson/Chairperson-Incharge of the concerned Department must ensure to follow the norms of Social Distancing during the Physical Counseling.
- 5. Counseling for admission to the programmes will be held from 10:30 a.m. onwards in the concerned Department as per schedule. No separate communication shall be sent in this regard.
- 6. Merit list of all eligible candidates shall be prepared as per criteria given in the Information Brochure/amendments made later on and shall be displayed on the Notice Board of the Department concerned and University Website as per schedule.
- 7. All the eligible candidates shall be required to appear physically before the Counseling Committee for verification of documents and checking of eligibility strictly according to the Counseling Schedule before the admission to the programme is made. They will be called for counseling one by one in order of merit.
- 8. Any candidate, who fails to turn up for Counseling at his/her turn, will be considered for the remaining seats at the time he/she reports for counseling, if the seat are vacant.
- 9. Counseling will be closed as soon as all the seats in each category are filled.
- 10. Those candidates, who do not get admission in any round of Counseling, shall be eligible for admission in subsequent round, if seats are available.
- 11. Seats, remaining vacant in one round of counseling, will be filled up in the subsequent round of counseling. The number of vacant seats shall be displayed on the Notice Board of the Department and on the University Website as per schedule.

- 12. The criteria for preparing the merit list for admission in M.A. Hindi, M.A. English, M.A. Economics, Master of Social Work and M.Sc. Yoga programmes will be the same as available in the Information Brochure 2020-21 of the University for the courses where admissions are to be made through Academic Merit.
- 13. The candidate, admitted during the counseling, shall deposit the fee on the date of counseling itself with the Oriental Bank of Commerce/Punjab National Bank located in the campus, failing which his/her admission shall stand cancelled.
